GUAY WINS FIRST C.THOMAS CLAGETT JR. MEMORIAL REGATTA

Newport, RI, August 24 –Joe Guay, Barrington, RI with crew Joe DeVecchio, E. Providence, RI, Rose-Marie Guay (wife of skipper) and Tim Jermain, Middletown, RI bested the field in a12 race series with near perfect 12-18K Narragansett Bay breezes. Skipper Guay, a paraplegic, was elated as he accepted the first perpetual C.Thomas Clagett Jr. Memorial Regatta trophy. “ I have worked for 11 yrs get on the podium” Guay stated, “I finally made it”.

Hosted by Shake-A-Leg, and Clagett family members, the 2-day regatta was the culmination of a 4-day teaching clinic/regatta designed to bring disabled sailors up to a Paralympic competitive level. Morning classroom sessions were followed by on-water coaching for the first two days. Scott Leppert, head sailing coach at Washington College and Erin Maxwell, #2 rank US Sailing Team 470 female skipper, did an outstanding job both on and off the water. “ I learned 5 years of racing skills in 4 days”, remarked one competitor.

Notice of Race

1. RULES:

The regatta will be governed by the 2001-2004 International Yacht Racing Rules; the prescriptions of U S Sailing and the Sonar Class Rules.

2. CLASSES:

Sonar One Design

3. ALTERATION OF RACING RULES: RRS-44.2, 720⁰ Turns Penalty, is modified so that only one complete 360⁰ turn is required to comply with the rule.

4. ELIGIBILITY:

The regatta is open to invited disabled US Sailing members and able-bodied crew. All competitors shall be classified as Group 1 or Group 2 (amateurs) as defined in The ISAF Sailors Classification Code.

Each Sonar team shall consist of three people at least one of which must have a physical disability.

5. WAIVER OF LIABILITY:

Each competitor must sign a Waiver of Liability to qualify entry.

6. SCORING:

The Low-Point Scoring System, Appendix A of the racing rules shall apply with a maximum of eight races scheduled of which two shall be completed to constitute a series. A boats worst score will be discarded if six or more races are completed.

7. SAILING INSTRUCTIONS:

The Sailing Instructions will be available at registration.

8. COURSES:

The Courses shall be described in the Sailing Instructions.

9. PRIZES:

Trophies will be awarded to the top 3 finishers.

Sailing Instructions

1. Rules

The Regatta will be governed by the 2001-2004 ISAF Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association (USSA) and the Sonar Class Rules.

2. NOTICES TO COMPETITORS – Notices will be displayed on Event Board at SA Sailors deck.

3. CHANGES IN THE SAILING INSTRUCTION

Attempts will be made to post any changes in the sailing instructions within a reasonable amount of time before competitors begin to board.

4. SIGNALS - Starting signal will be in accordance with racing rule 26

5. SCHEDULE OF RACES – Best attempt for 6 races per team. 2 races constitutes a series. 6 races, one throw out.

5.2 Should wind, weather, or other conditions make it impossible to complete the normal number of races, the series shall be terminated and the results based on the number of races completed. The Race Committee & Judges shall determine such termination and decisions regarding results.

6. RACING AREA

The racing area will be Newport's outer harbor.

7. The Course:

Shall be Windward/Leeward (W) or Modified Windward/Leeward (M). All turning marks shall be rounded to port. Course, magnetic bearing to the first mark, and number of legs will be displayed on a white board aboard the R/C boat.

8. Marks – will be orange inflatable balls.

9. THE START

9.1 . The starting line will be between the flag on the Race Committee signal boat and the starting mark.

10. RECALLS

10.1 Individual recalls will be signaled by one horn and the sail number of the yacht(s) recalled will be hailed.

11. CHANGES OF THE COURSE AFTER THE START. Shall be in accordance with Rule 33.

12. THE FINISH

The finishing line will be between a staff on the race committee boat and the starting mark.

13. TIME LIMIT

13.1. Is 45 minutes per race

13.2 If a yacht in last place in a race is delaying the next start, the race committee may order the race terminated and score the yacht points equal to last place.

14. RETIREMENT

A yacht that retires from a race is asked to notify a race committee boat before leaving the race area. If that is impossible, then immediately after arriving ashore, the competitors shall notify a regatta representative.

15. PROTESTS

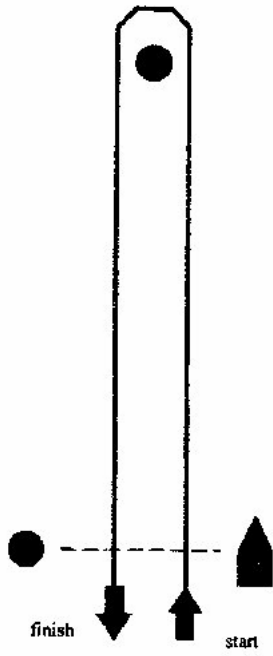
15.1 Yacht shall notify the finish line committee boat of her intent to protest and the number of the protested yacht. Decisions of the protest committee shall be final. Competitors responsible for their own red protest flag

15.2 – Rule 44.2 "Turns Penalty " to be amended from 720 deg to 360 deg penalty

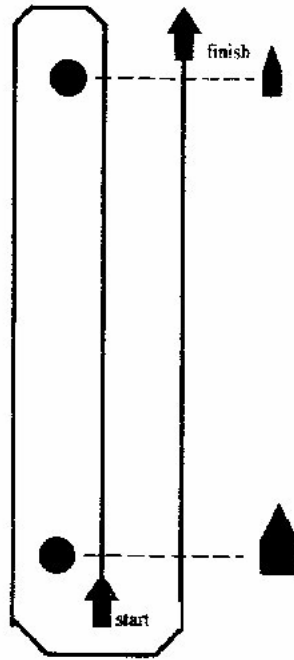
16. SCORING- Shall be low point in accordance with Appendix rule A , modified as 1st place finisher will receive $\frac{3}{4}$ point.

17. PFDs must be worn at all times while sailing.

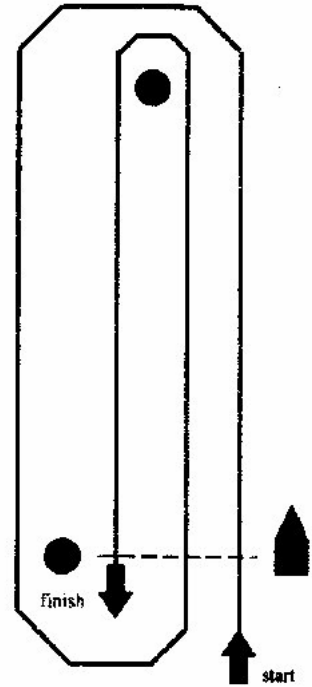
Regatta Course Descriptions



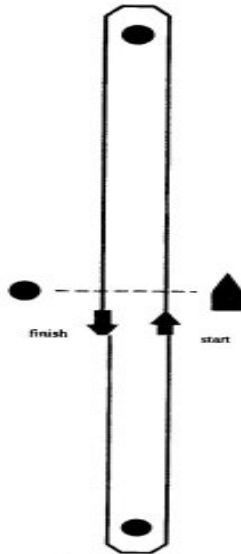
